Alberta Seniors Benefit (ASB)

Are you 65 years or older?

- No → Stop: You are not eligible for senior benefits.
 Yes → Continue.

Have you lived in Alberta for at least three months?

- No → Stop: You must reside in Alberta for at least three months.
 Yes → Continue.

Is your income below:
\$33,410 if single, or
\$54,640 if couple?

- No → Stop: You may not qualify based on income.
 Yes → **Apply:** Online.

Dental and Optical Assistance for Seniors

Do you need help covering dental or optical costs?

- No → Stop: This benefit only covers dental and vision expenses.
 Yes → Check eligibility: **Single senior:** \$0 to \$33,410
Senior couple: \$0 to \$66,820
Apply: You must first qualify for Seniors Financial Assistance Programs

Special Needs Assistance for Seniors

Do you have a one-time need for items like appliances or home help?

- No → Stop: This is specific to essential items or health supports.
 Yes → Continue.

Is your income below:
\$33,410 if single, or
\$54,640 if couple?

- No → Stop: You may not qualify based on income.
 Yes → You qualify!
Apply: Complete Seniors Financial Assistance Form

Supplementary Accommodation Benefit (SAB)

Are you a senior in designated supportive living or long-term care?

- No → Stop: This benefit is specific to long-term care.
 Yes → You may be eligible for up to \$710/month to cover additional care costs.
Eligibility: Automatically added if you qualify for ASB. Contact AHS 780-842-3324

Coverage for Seniors Program

Do you need help with prescription drugs, diabetic supplies, or ambulance services?

- No → Stop: This program only covers specific healthcare needs.
 Yes → Automatically provided if you're enrolled in Alberta Health Care.

Seniors Property Tax Deferral Program

Do you own your home with at least 25% equity?

- No → Stop: This program requires homeownership with equity.
 Yes → You may qualify to defer property taxes.
Apply: Download Application Form

Seniors Home Adaptation and Repair Program (SHARP)

Do you need help financing home repairs or adaptations for safety?

- No → Stop: This benefit is specific to home safety modifications.
 Yes → Continue.

Is your income below \$75,000, with at least 25% home equity?

- No → Stop: You may not qualify based on income or equity.
 Yes → You may qualify.
Apply: SHARP Application
